SCHOLARSHIP APPLICATION INSTRUCTIONS

1. Families may be awarded each type of scholarship (local and national) no more than once per year.
2. Priority will be given to those who have paid dues.
3. Conference/convention topics must relate to Down syndrome.
4. Please allow sufficient time for processing and plan accordingly. The Board meets once a month (2nd Monday of the month). **Be sure to attach/include the conference brochure containing registration details.** Completed applications should be emailed to finance@dsafnebraska.org or mailed to

5. Awards are approved at the Board's discretion.
6. Each applicant will receive an approval or denial letter by email, upon action by the Board.
7. Additional funding sources are allowable, however, DSAF will not award more than the cost of the conference/registration given all funding sources. When additional funding sources are available to a family, DSAF will ask for details of those funding sources.
8. For local conferences, DSAF will award a scholarship for ½ of the registration fee, up to a \$ 75 award. Proof of payment will be required and DSAF will reimburse the family. Reimbursement details will be explained in the approval letter.
9. For national conventions, DSAF will award a scholarship for up to \$ 500 towards registration fees, lodging and travel costs. Whenever possible, DSAF will pay the registration directly. Lodging and travel costs will be reimbursed after proof of payment is received. Payment/reimbursement details will be explained in the approval letter.
